 - (1) i.e. Do NOT enter NY amounts in NJ line just leave blank
 - ii) See TW State Help for NY for special codes
 - (1) box 20, Local name (e.g. NYC, YONKERS, FORM1127)
 - (2) box 14, Other (e.g. 414HSUB, IRC125S)
- c) RES/NR Wkt will be Red ok for now
- d) Run Diagnostics to check for federal problems
